- i. site selection.
- Co-develop and assist the implementation of project plan
- Build good working relationship with site and SCRI team.
- Monitoring site progress to ensure that project is on schedule.
- Escalate any issues from site to project manager promptly, eg. Data queries
- Other supporting activities to assist project managers
